PROCEDURE FOR BUILDING SEWER CONNECTION TO CREEKVIEW SEWER LATERALS

The procedure for the building sewer connection shall be as follows:

• COMPLETION OF APPLICATION AND PAYMENT OF FEES

The owner and/or contractor shall complete the Strasburg Borough Authority Connection Application and the Strasburg Township Connection Application and provide all fees and agreements required. The application shall be accompanied by a sketch of the proposed connection. The sketch shall provide all material specifications. Attached are applicable Strasburg Borough Authority details that will be required for your connection.

Note: If grinder pump is required for connection the pump shall be an Eone pump. The Township will supply pump at Twp cost to owner.

• LATERAL INSPECTION:

After the building sewer has been installed but before backfilling, the Applicant shall schedule an inspection with the Strasburg Borough Authority (717-687-6233) Commonwealth Code Inspection Service (Pete Kingsley 717-278-0964) shall inspect all completed electrical connections if a grinder pump is required. The fee per inspection is \$60 and is the owner's responsibility. The owner shall prearrange the inspection a minimum 24 hours prior to the request for inspection date and time.


DECOMMISSIONING ON-LOT SEWER SYSTEM:

The owner is required to decommission the existing sewage system. All existing sewage tanks shall be pumped to remove the effluent prior to decommissioning with one of the following methods:

- 1. Remove tanks and backfill with suitable soil.
- 2. Crush tanks in place and backfill with suitable soil.
- 3. Completely fill existing tanks with sand or aggregate material.















AGREEMENT

THIS AGREEMENT made as o	f the day of	, 2024, by

its municipal offices located at 400 Bu	nker Hill Road, Stras	sburg, Pennsylvania 17579 (the
"Township"), and	, adult i	individuals and husband and wife

("Landowners").		

BACKGROUND

Landowners are the record owners of a tract of land within Strasburg Township, Lancaster County, Pennsylvania, identified as _____ Creekview Lane by virtue of a deed recorded at Document No. _____ in the Office of the Recorder of Deeds in and for Lancaster County, Pennsylvania (the "Property"). In accordance with the Township Official Sewage Facilities Plan and the regulations of the Pennsylvania Department of Environmental Protection ("DEP"), the Township undertook a project to extend public sewer service to all properties fronting along Creekview Lane and certain properties fronting on Edisonville Road (the "Project"). As a result of the Project, the Property is now able to connect to and use the public sewer system.

The total construction cost of the Project was \$424,106, exclusive of design and inspection costs. The Township was able to defray a portion of the cost of the Project using federal funds, resulting in a net construction cost, exclusive of design and inspection, of \$183,596.

The Project served eighteen lots. The per lot cost of the Project after subtracting federal funding and the design and inspection costs is \$10,199.78 per lot. The Township has also waived its administrative fee of \$150 per connection to the public sewer system for each lot served by the Project.

Wastewater flows from the Project will be treated at the Strasburg Borough, Lancaster County Authority wastewater treatment plant. Strasburg Borough, Lancaster County Authority imposes a tapping fee of \$5,661 per equivalent dwelling unit ("EDU").

Landowners acknowledge that Landowners are responsible to pay the assessment of \$10,199.78 for the extension of public sewer service to the Property (the "Assessment") as well as

one tapping fee in the amount of \$5,661 which the Township is required to pay to Strasburg Borough, Lancaster County Authority. Landowners have requested that the Township allow Landowners to pay the Assessment over time as part of the quarterly sewer rates. The Township has agreed to allow such payment of the Assessment over time at an interest rate of one (1%) percent under the terms of this Agreement.

NOW, THEREFORE, for and in consideration of the mutual promises contained herein, and intending to be legally bound hereby, the parties agree as follows:

- 1. The foregoing background recitals are incorporated into and made a substantive part of this Agreement.
- 2. Landowners shall connect the dwelling on the Property to the public sewer system on or before June 30, 2024, and shall pay the required tapping fee of \$5,661 in full prior to the issuance of a permit to enable such connection.
- 3. Landowners agree that the Assessment for the cost of the Project in the amount of \$10,199.78 is fair and reasonable and that the Township may file a municipal lien against the Property in the amount of \$10,199.78, together with the filing fees imposed by the Lancaster County Prothonotary and attorneys' fees incurred in the preparation of the municipal lien to secure payment of the Assessment (collectively the "Lien Costs").
- 4. Landowners acknowledge that they agree to pay the Assessment and Lien Costs as part of their quarterly billings for sewer service to the Property. Landowners expressly acknowledge that the quarterly billing will include the wastewater collection, conveyance, and treatment fees which, as of the date of this Agreement, are \$147.15 per quarter, which amount is subject to change, and \$140.73 representing the repayment of the Assessment and Lien Costs plus interest at the rate of one (1%) percent.
- 5. The Township shall satisfy the municipal lien at the time that all outstanding sums, plus interest accrued, are paid in full.
- 6. If Landowners convey the Property, Landowners shall make payment to the Township in the full amount necessary to pay the Assessment, Lien Costs, and all accrued interest.
- 7. If Landowners fail to make the payments set forth in this Agreement, the Township shall have the right to take all actions authorized by law to enforce its municipal lien and to collect all sums due and owing under this Agreement and, if applicable, delinquent sewer rates.
- 8. The parties agree that the foregoing constitutes the entire agreement between them and that there exist no other agreements, oral or written, between them relating to any matters covered by this Agreement.

- 9. This Agreement may be amended only by written instrument signed on behalf of the Township and the Landowners.
 - 10. Landowners represent that they constitute all of the record owners of the Property.
- 11. Landowners acknowledge that the Township will record this Agreement in the Office of the Recorder of Deeds in and for Lancaster County, Pennsylvania, to give notice to persons of the terms of this Agreement related to the Project and the requirement that Landowners pay the assessment to the Township. Landowners and the Township agree that the satisfaction of the municipal lien referenced herein indicates that Landowners have complied with the terms of this Agreement and no further payments under this Agreement are required to be made to the Township.
- 12. This Agreement shall be binding upon and shall inure to the benefit of the parties and their respective personal representatives, heirs, successors and assigns.
